<u>Land Use Variance</u>: To allow for a restaurant with alcohol in a Neighborhood Commercial "NC" district whereas the ordinances state that this is not a permitted use within the district.

Plan Director Paul Munoz stated that this item would need to be tabled as the Legal Notice was not properly published in the Noblesville Daily Times. Paul Munoz explained that his office submitted the correct information on the Legal Notice, but the date was not published correctly.
