



Small Business COVID-19 Grant Program

Background:

The Town of Cicero received funding through the Office of Community and Rural Affairs' (OCRA) COVID-19 Response Program. OCRA's funding is through the agency's Community Development Block Grant (CDBG) program, which they receive through the federal Housing and Urban Development (HUD). These funds must meet a National Objective to qualify and to be eligible, so there is no guarantee of funding once your application is submitted.

The intended purpose of the Cicero Small Business COVID-19 Grant Program is to assist our local businesses during this pandemic. The funding has been broken down into three areas, which have been outlined within this application. The Cicero Small Business COVID-19 Grant Program will have limited funding; therefore, not all grant requests may be approved or approved at the level requested.

Ineligible Industry Sectors:

If you are in industry sectors not significantly affected by the public health crisis related to COVID-19, or not meeting other requirements listed herein, are unlikely to be funded through this grant program. Examples of those industry sectors would include, but is not limited to; gas stations, grocery stores, temporary online residential rentals such as VRBO and/or Air BnB, apartment buildings, construction businesses, and marinas.

Eligible Businesses/Industry Sectors:

If you are an eligible business and are able to apply, the following information outlines the process of this grant and what to expect through this process.

Eligible Business Requirements to Apply:

1. Must be in good standing with regard to state and local taxes, licenses, and code compliance.
2. Must be in good standing with the Indiana Secretary of State.
3. Must have been established and operational in the Town of Cicero since January 1, 2020.
4. Businesses that have expanded to a storefront from another business are eligible (for example, an online retailer who opened a boutique or a pop up shop that opened a brick and mortar business).
5. Each application will be reviewed to determine eligibility through the CDBG's National Objective.
6. Must agree to continue business operations in the Town of Cicero for at least two (2) years after grant date.



Eligible Uses of Funding:

1. **Rent and Utility Assistance:** A grant of up to \$1,500.00/month for a 3 month period of time that would go directly towards rent and utility costs for the business.
2. **Payroll Assistance:** This program would assist businesses that have been able to move to a no contact or curbside service while continuing to employ their store clerks, inventory specialists, wait staff, etc. by assisting with payroll for those LMI jobs in our restaurant and retail industry. Businesses can apply for grant assistance for up to \$1,000.00/month for up to 5 employees (who would qualify under the CDBG National Objective of eligibility).
3. **Expansion of Business Services:** This will provide funding for businesses to expand their current business model that can better utilize technology in today's business climate. This would include, but would not be limited to, the purchase of new hardware or software, the development of new sales and delivery methods, or other operation needs that would expand the services of the business. Funding would be for up to \$2,500.00.

Maximum Grant Amount: The maximum grant amount is \$8,000.00 per business. Funding can be through 1 of the 3 eligible activities or a combination of all three, but the amount is not to exceed \$8,000.00. There will NOT be a grant match for this program.

Application and Review Process:

1. The Cicero Small Business COVID-19 Grant application will be available beginning Thursday, May 14, 2020.
2. All applications will be due by Monday, June 1st by 3:00pm.

5. Applications will be reviewed and scored by the Cicero Small Business Grant Committee, comprised of Council Members Dan Strong and Chad Amos, Dea Holt (Our Town Cicero), Shae Kmicikewycz (Town of Cicero), Sarah Buckner (Cicero Economic Development Committee), and Rhonda Gary (Cicero Clerk Treasurer, non-voting).
6. The Office of Community and Rural Affairs will review the recommended applications from the Town of Cicero to determine eligibility as well as meeting the National Objective for Low to Moderate Income (LMI).



7. An award announcement will be made the week of June 22, 2020.
8. Financial data will be kept confidential to the extent permitted under the law.
9. Applicants understand and accept that the Town of Cicero is a public entity subject to various laws and regulations requiring disclosure of documents and records such as the Indiana Access to Public Records Act. By submission of an application, the applicant is thereby consenting to Cicero making any and all required disclosures of the data within said application.
10. Preference will be given to businesses that have:
 - a. Demonstrated a commitment to the community, through the support of local youth or charitable programs, good corporate citizenship, participation in community and business support organizations.
 - b. Plans to hire, train or assist individuals who lost jobs or experienced economic hardship during the COVID-19 emergency.
 - c. Needs that have not been or are not anticipated to be addressed through other government assistance programs like the Small Business Administration or the Indiana Small Business Development Center.
 - d. Has not received abatements from the Town previously.
 - e. Has made all reasonable efforts to keep employees employed during the recovery process.
 - f. Is in an industry sector particularly affected negatively by COVID-19 and public safety measures associated with the outbreak (for example: retail, dine in restaurant, salon).
 - g. Are not part of a franchise network.
 - h. Have a physical location in the Cicero Town limits.
 - i. Had 50 or fewer employees as of March 1, 2020.
