6. <u>Plan Director's Report</u>: Enclosed in your packets. October another good month for plan department. Had revenue of \$15800, ending October ahead of the year of 2019. Permits 31 building, 20 Cicero with 11 in Jackson Township. MI Homes has 29 homes in Section 2, starting section 3. Looking to pave next week, opening up options for 12 more homes (duplexes) to hopefully keeping them busy thru the winter without interrupting the building.

Attended an Energy Code class-to continue growth with inspections.

Mr. Schrumpf commented the duplexes seem to be growing fast with seniors. Mr. Taylor stated calling the duplex community "Age targeted". Not sure of the age group but definitely empty nesters. Discussion on the community and favorable comments all around.
